

**Notice on the processing of personal data**  
**via video surveillance system**

**1. Data Controller:**

The société anonyme under the trade name "LINDOS OLYMPIA INTERNATIONAL VILLAGE SINGLE MEMBER SOCIÉTÉ ANONYME" and distinctive title "LINDIAN VILLAGE", having registered office in Kifissia, Attica, at 99 Vassileos Othonos Str, under G.E.MI. no. 161996301000 and TIN 801713085, as duly represented (hereinafter referred to as the "**Company**").

**2. Purpose and Legal Basis for Processing:**

A surveillance system operates on our premises for the purpose of securing the safety of persons and goods. The processing is necessary for the legitimate interests of our Company as data controller (Article 6(1)(f) of the GDPR).

**3. Analysis of Legitimate Interests:**

Our legitimate interest consists in the need to protect our premises, and the goods located there from unlawful acts (e.g. theft, destruction of property, etc.) and especially for the safety of life, physical integrity, health and property of our visitors and employees as well as third parties who are lawfully present in the monitored area. We only collect image data and limit the collection to places where we have assessed that there is an increased likelihood of illegal acts being committed, without focusing on places where the privacy of the persons whose image is taken may be unduly restricted, including their right to respect for their personal data. To this end, a special mark has been placed regarding the operation of this system, in accordance with the requirements of the applicable national and European legislation and in compliance with the instructions of the Hellenic Data Protection Authority.

**4. Recipients:**

The recorded material is accessible exclusively by specially authorized personnel, responsible for the security of the premises. This recorded material shall not be shared with third parties except in the following cases:

- i. Disclosure to the competent judicial, prosecutorial and police authorities where it contains information necessary for the investigation of a criminal offence involving persons or property of the data controller.
- ii. Disclosure to the competent judicial, prosecutorial and police authorities if they lawfully request the data in the course of their duties.
- iii. Disclosure to the victim or perpetrator of a criminal offence, where the data are data which may constitute evidence of the offence.

**5. Retention Period:**

The abovementioned data are retained by our Company for a period of fifteen (15) days, after which they are automatically deleted. In case of an incident being detected during this period, part of the footage will be isolated and retained for up to one (1) additional month for investigation purposes. If legal proceedings are initiated, the relevant material may be retained until a final legal decision is issued.

**6. Rights of Data Subjects:**

Data subjects may exercise all the rights provided by European and national law, including:

- Right to Information (You may request information regarding the nature and purpose of the processing, as well as the measures taken to protect your data).
- Right of Access (You have the right to know whether your image is being processed, and if so, to receive a copy of it).

- Right to Rectification (You may request the correction of inaccurate data or the completion of incomplete data relating to you).
- Right to Restriction (You may request the restriction of processing of your data).
- Right to Object (You may, under certain legal conditions, object to the processing of your data).
- Right to Erasure (Right to be Forgotten) (You may request the deletion of your data).
- Right to Data Portability (You may, under certain conditions, request the transfer of your data to another data controller).

You may exercise your rights by sending an email to [info@lindianvillage.gr](mailto:info@lindianvillage.gr) or submitting a written request at the reception of our premises. In order for us to process a request related to your image, you will need to tell us approximately when you were in range of the cameras and provide us with an image of you to help us identify your data and hide the data of third party subjects. Alternatively, you can come to our premises and we can show you the images in which you appear. We also point out that the exercise of a right to object or erasure does not imply the immediate deletion of data or the modification of processing. In any case, we will respond to your request as soon as possible, within the deadlines set by the GDPR.

#### **7. Right to Lodge a Complaint:**

If you believe that the processing of your data violates Regulation (EU) 2016/679, you have the right to lodge a complaint with the Hellenic Data Protection Authority. For further information, you may visit the official website of the competent supervisory authority at [dpa.gr](http://dpa.gr).

#### **8. Security and Maintenance of Systems:**

Cameras and recording systems undergo regular maintenance to ensure their optimal functionality and security. The Company implements all necessary technical and organizational measures to safeguard data protection.
